1. Application shall be completed and signed.
2. All appropriate fees shall accompany the application.
3. You **must** stay within your rented space.
4. No re-selling of Chamber of Commerce spaces allowed.
5. No vending of any kind of **animals, birds, or reptiles** allowed.
6. No alcoholic beverages allowed.
7. No pornographic materials, drug paraphernalia, or tobacco products allowed.
8. No firearms or weapons (new, used, or antique) allowed.
9. No smoke bombs or fireworks of any kind allowed.
10. No dumping of waste water or grease in.
11. Set-up times will be indicated on your confirmation letter with your assigned space.
12. All vendors must clean their spaces, remove all garbage and discard.
13. Absolutely no selling of raffle tickets of any kind without the express written permission of the Chamber of Commerce.
14. Refunds must be requested in writing no later than June 1st.
15. Bring your confirmation of assigned space.

1. **You, the vendor, are responsible for obtaining and displaying a current valid NYS Tax ID. Make sure you list your sales from this event on the ST-100 under Warren County. Food vendors are also responsible for obtaining and displaying a current valid Health Certificate.**

2. There is no security provided for your property or merchandise.
3. We reserve the right to place you in any available space of the size you have requested.
